#### **Public Responses:**

- Build out our transit system and bicycle network
- Support the proliferation of reliable and abundant EV charging
- Use more solar
- Focus on how transportation and the UDO are going to allow our city to grow so people don't need to depend on cars to get around
- Ensure we have the energy generation to support our goals.



SEAP+ Question:
What is the single most impactful action you believe the City of Charlotte could take to accelerate progress towards its Municipal Goals?

#### **Public Responses:**

- Promoting the retrofitting of older homes to help reduce power bills
- Hybrid or battery vehicles should be the absolute priority for take home vehicles where the employee lives outside the city limits
- Make transportation system more pedestrian-friendly
- Protect green areas in Charlotte

#### **Public Responses:**

- Promote EVs to our community
- Ride the light rail
- Continue to plant trees in partnership with TCPP and CM Storm Water Services



### FY2025 Approach

- 1. Continuing to lead by example as a municipality through sustainable infrastructure investments that lowers our carbon footprint and supports a healthy community.
- 2. Laying the groundwork to harness external funding opportunities to make our dollars go further.
- 3. A strategic and amplified focus on equity and engagement towards our 2050 goal to become a low carbon community.



# 1) Lead by Example

- ✓ 30 on-site solar systems + secured an off-site 80MW solar project
- ✓ Only 19% to go to hit zero carbon building goal
- ✓ NAFA 6<sup>th</sup> greenest fleet with 330 city-owned EV charging ports
- ✓ Broke ground on All-Electric Fire House & Electric Fire Truck
- ✓ Sustainable Facilities Policy Update Won Local Gov Impact Award

**BLOOMBERG AMERICAN SUSTAINABLE CITIES** 



Department of Energy, Energy Efficiency & Conservation Block Grant to support a Solarize Campaign which is anticipated to facilitate **the installation of about 1,500 rooftop solar systems** as well as including direct solar **installs on about 35 low- and moderate-income households.** Program set to launch in late Spring.

# 3) Strategic Focus on Equity & Engagement

- GreenPrints- an environmental justice addendum to the Corridors of Opportunity playbooks with partners Clean AireNC and Sol Nation.
- ➤ EV Car Share- electric vehicle car share program at/near four affordable housing sites with Forth Mobility (DOE grant)Q1 2025
- ➤ **Duke Energy + City High Energy Use Pilot** to ensure that critical home rehabilitation is completed enabling energy efficiency retrofits
  - ➤ Served 54 homes, with 42% of the homes requiring city dollars to enable the energy efficiency work
  - ➤ For every \$1 Charlotte spends, Duke spends ~\$2.
