## RESOLUTION PASSED BY THE CITY COUNCIL OF THE CITY OF CHARLOTTE, NORTH CAROLINA ON SEPTEMBER 22, 2025

A motion was made by	and seconded
by	for the adoption of the following Resolution, and
upon being put to a vote was duly	adopted:

- WHEREAS, The Federal Clean Water Act Amendments of 1987 and the North Carolina the Water Infrastructure Act of 2005 (NCGS 159G) have authorized the making of loans and grants to aid eligible units of government in financing the cost of construction of (state whether a wastewater treatment works, wastewater collection system, stream restoration, stormwater treatment, drinking water treatment works, and/or drinking water distribution system or other "green" project), and
- WHEREAS, The <u>City of Charlotte</u> has need for and intends to construct one clean water project described as the Ashe Plantation Lift Station and Forcemain Replacement, and
- WHEREAS, The City of Charlotte intends to request state loan assistance for the project,

## NOW THEREFORE BE IT RESOLVED, BY THE CITY COUNCIL OF THE CITY OF CHARLOTTE:

That the <u>City of Charlotte</u>, will arrange financing for all remaining costs of the project, if approved for a State loan award.

That the <u>City of Charlotte</u> will adopt and place into effect on or before completion of the project a schedule of fees and charges and other available funds which will provide adequate funds for proper operation, maintenance, and administration of the system and the repayment of all principal and interest on the debt.

That the governing body of the <u>City of Charlotte</u> agrees to include in the loan agreement a provision authorizing the State Treasurer, upon failure of the <u>City of Charlotte</u> to make scheduled repayment of the loan, to withhold from the <u>City of Charlotte</u> any State funds that would otherwise be distributed to the local government unit in an amount sufficient to pay all sums then due and payable to the State as a repayment of the loan.

That the <u>City of Charlotte</u> will provide for efficient operation and maintenance of the project on completion of construction thereof.

That the <u>City of Charlotte</u>, <u>Angela Charles (Director)</u>, and successors so titled, are hereby authorized to execute and file an application on behalf of the <u>City of Charlotte</u> with the State of North Carolina for a loan to aid in the construction of the project described above.

That, if accepted into the loan program by the State, Angela Charles (Director) and successors so titled, individually or collectively, are hereby authorized to execute and accept a loan offer on behalf of the <u>City of Charlotte</u> with the State of North Carolina for a loan to aid in the construction of the project described above in an amount not to exceed \$10,000,000 plus or minus 10% in accordance with the loan program based on actual project costs.

That <u>Angela Charles (Director)</u>, and successors so titled, are hereby authorized and directed to furnish such information as the appropriate State agency may request in connection with such application or the project: to make the assurances as contained above; and to execute such other documents as may be required in connection with the application.

That the <u>City of Charlotte</u> has substantially complied or will substantially comply with all Federal, State, and local laws, rules, regulations, and ordinances applicable to the project and to Federal and State grants and loans pertaining thereto.
