► 2024 Legislative Sessions





General Assembly passed the 2023-2025 State Budget

- Casino gaming is not part of the budget
- \$20 million is appropriated for Project Breakpoint
- Fuel sales tax exemption for commercial air carriers is extended for another five years

Governor has stated he will allow budget bill to become law without his signature

Since Medicaid Expansion was tied to enactment of the budget, Governor announced that it will launch in North Carolina on December 1

Transportation Funding

- Continues full funding for the NC Airport Improvement Program and State Maintenance Assistance Funding for transit
- Continues reduced funding for the city's Powell Bill allocation at 2/3 of the FY 2020 allocation

Bond Referendum Language

- Requires additional language in the ballot question that provides:
 - Estimated cumulative cost of issuing debt, i.e. both principal and interest
 - Statement that additional property taxes <u>may be levied</u> to pay the principal and interest
- Effective for bond referendums conducted on or after December 31, 2023

Mecklenburg Meals Tax Extension

- Rep. Bradford has been working diligently to advance the Mecklenburg meals tax extension
- Extension was added by House along with numerous other occupancy tax measures to Senate legislation (SB 154 – Hise), which was rejected by the Senate
- Extension is also in a conference report (HB 5 Pare') that is awaiting House and Senate action

Regulatory Reform Act of 2023 (HB 600 – Riddell)

- Sen. Salvador secured amendments to ensure the Stormwater Fund would not face a significant unfunded mandate of \$17 million per year
- HB 600 has passed House and Senate and sent to the Governor for consideration

House and Senate are pivoting to redistricting

- House maps adopted by the NC Supreme Court were only valid for the 2022 general elections
- Anticipating that changes will be made to NC Senate and Congressional districts
- Filing for House and Senate seats begins in early December

Senator Berger anticipates votes on new maps could take place as early as the week of October 9

2023 Issues Still on the Table

Landlord – Tenant and HOA Changes (HB 551 – Bradford):

 Secured amendment to ensure city's Source of Income Discrimination policy in city supported housing can continue

Land Use Clarifications and Changes (SB 675 – Lee):

 Secured amendments to ensure that the city's extraterritorial jurisdiction powers would not be repealed

<u>Revise Pharmacy Benefit Manager Provisions (HB 246 – Sasser):</u>

- Received commitment from bill sponsor that city requested amendment will be added to exempt local government self-funded benefit plans
- Prevents \$4 million cost increases to employee benefits programs

2023 Issues Still on the Table

Backflow Preventers / Local Authority (SB 166 – Krawiec):

• Convened stakeholder's group, with the blessing of the House floor manager, to develop consensus amendments

Regulation of Accessory Dwelling Units (HB 409 – Winslow):

 Seeking amendments to HB 409 to ensure city's policies remain in place

Legislation purports to lower the cost of development:

- Surveyors Right of Entry / Expedite Commercial Building Inspections (SB 677– Jarvis)
- Private Commercial Building Inspections (HB 893 Brody)

2024 Legislative Sessions

► 2024 is Presidential election year

- One-third of US Senate
- US House of Representatives
- Governor and Council of State offices
- NC General Assembly
- County Commissions

2024 legislative schedules

- NC General Assembly Mid-May convening to late-June adjournment
- US Congress More frequent and longer in-state and district work periods

► Focus of 2024 is on finishing up work leftover from 2023
