	for the adoption of the following Resolution, and upon
being put to a vote was dul	y adopted:

WHEREAS, Professional Police Services Inc. ("PPS") is an accredited company police agency authorized by the Attorney General of North Carolina in accordance with Chapter 74E of the North Carolina General Statutes; and,

WHEREAS, the City and PPS entered into an Agreement dated July 15, 2023, for PPS to provide security service on City property utilized for transit purposes; and,

WHEREAS, North Carolina General Statute § 74E-6(h) permits the City and PPS to enter into a mutual aid agreement to extend the territorial jurisdiction of PPS beyond the real property owned or in the possession of the City, which is utilized for transit purposes; and,

WHEREAS, the City of Charlotte seeks to improve the utilization of and safety of the transit system by expanding the territory jurisdiction of PPS; and,

NOW, THEREFORE, BE IT RESOLVED by the City Council for the City of Charlotte, pursuant to Chapter 74E-6(h) of the North Carolina General Statutes that:

- The City Manager, his designee, or the Charlotte Area Transit System CEO (or Interim) is hereby authorized to enter into a mutual aid agreement with PPS expanding their jurisdiction at the following locations:
  - a. Charlotte Transportation Center all sidewalks adjacent to the transit facility, bounded by 4th Street, South Brevard Street, and East Trade Street, extending to the boundary of City-owned property beneath the train tracks. This does not include the property located at 210 E. Trade Street (commonly known as the Epicenter or Queen City Quarter)
    - 303 East Trade and the adjacent area under the train tracks located on City-owned property.
    - ii. The median on East Trade Street (between 303 E. Trade St. and 310 E. Trade Street) beneath the train track on City-owned property.
    - iii. The entity of the sidewalk from E. Fourth Street and Brevard St. extending toward S. College St., ending beneath the train tracks on City-owned property.

- Rosa Parks Community Transit Center- 2811 Beatties Ford Rd. all sidewalks adjacent to the transit facility bordered by Rosa Parks Place and Beatties Ford Rd.
- c. Rail Trail- The entirety of the Charlotte Rail Trail.
- d. The Eastland Community Transit Center is located at 5401 Central Ave. All sidewalks, parking lots, and other areas adjacent to the transit facility have an external boundary of Central Ave, Sol East Ave, Eastland Yards Blvd, and Movement Ave.
- 2. The mutual aid agreement shall not exceed a period of five (5) years.
- 3. PPS shall continue to coordinate and work with the Charlotte-Mecklenburg Police Department.
- 4. Nothing in this Resolution shall impact, reduce, or limit the jurisdiction of the Charlotte-Mecklenburg Police Department, any other law enforcement agency, or common law officers granted by the North Carolina General Statutes.
- 5. This resolution shall take effect immediately upon its adoption.
