

## What are Digital Kiosks?

#### **Digital Kiosks Features**

- ☐ Free standing, interactive signage with digital touchscreens that:
  - Are a zero cost to the City to implement
  - Are installed in the public right-ofway
  - ☐ Provide wayfinding tools
  - Are ADA-compliant, multilingual, and accessible
  - Are installed and maintained by IKE Smart City
  - Display both public information and advertising



### Key Functions of the Kiosks

Display commercial ads (city receives revenue share)

Offer interactive tools for navigation and services

Provide free public Wi-Fi to immediate area

Highlight local businesses, including MWSBEs

Ability to deliver emergency alerts and emergency calling

Ability to integrate security cameras

Provide city content (events, wayfinding, alerts)

Displays both photo and video content






### Strategic Kiosk Placement 1

#### <u>Proposed Kiosk Locations</u> – 30 kiosks total

- Corridors of Opportunity & MSD's
  - 1. Beatties Ford/Rozzelles Ferry
  - 2. Albemarle/Central
  - 3. Freedom/Wilkinson
  - 4. North Tryon/North Graham
  - 5. West Sugar Creek
  - 6. West Boulevard
  - 7. South End Municipal Service District
  - 8. University City Municipal Service District
  - 9. South Park Municipal Service District



### **Contract Overview**


- No cost to City for deployment or maintenance of 30 kiosks
- 10-year term with optional 10-year renewal
- Revenue Generated for the City:
  - Greater of 30% net ad revenue or
  - Minimum annual guarantee \$8K/kiosk/year (30 kiosks)
    - 10% minimum annual guarantee increase at years 6, 11, 16

- Council Action
  - Ordinance changes required
    - Revise **Sec. 10-141** to allow digital kiosk as a form of signage in right-of-way
    - Revise **Sec. 19-208** to allow for illuminated signs in right-of-way
  - Contract Approval
- Cross-departmental collaboration
- Stakeholder engagement
- Kiosks permitting and installation
