


BUSINESS OPPORTUNITY HUBS



GOAL

Locate a business opportunity hub in each of the six corridors that will act as a physical space to connect small business owners, entrepreneurs and residents to financial assistance, access to capital, job opportunities and more. The six hubs will reduce barriers that underserved and underrepresented small business owners, entrepreneurs, and corridor residents face in accessing programs and resources needed to recover, grow, stabilize, start their business, or find employment.

PROGRAM CRITERIA AND PROCESS

Opportunity Hub operators were selected through an open RFP process led by the Corridors of Opportunity team and managed by project consultant Schermco. Application selection criteria prioritized existing organizations providing small business and workforce services and looking to expand their presence into the Corridors.

The Operators will provide services that respond to each corridor's needs and also serve as a front door to all services available through all six hubs. All hub operators will participate in a cohort model together over the next three years. Schermco will manage cohort activity and assist with program monitoring and impact metrics.

The cohort model will ensure residents and businesses in each corridor have direct access to the broader range of programs, services, resources and trainings available from all six operators.

- Schermco will also establish the cohort model among all operators. The cohort model will provide

 - o regular and routine communications between the hub operators
 - o connections to workforce and small business providers across Charlotte
 - uniform contract performance monitoring and impact metrics
