### 4. Policy Referral: Small Business Support

#### **Explanation**

On September 22, 2025, the Mayor asked the Jobs and Economic Development to review current programs and initiatives that support small businesses, determine any additional considerations needed to support Charlotte's small business ecosystem, and determine any recommended policies or approach for consideration from Council. As background, the Neighborhood Equity and Stabilization Commission (NEST Commission) made recommendations that included goals of empowering businesses and emphasizing the importance of retaining legacy businesses and supporting local entrepreneurship as the City invests in the growing infrastructure needs. The committee should also consider how the city can partner with Mecklenburg County to ensure measures are in place to mitigate small business displacement pressure where infrastructure investments are being made.
