

The site is currently zoned I-2(CD) via petition 1979-035(C). All contiguous parcels are zoned either I-1 or I-2 and developed with industrial uses.




The site, marked by a red star, is surrounded by many industrial uses.

## • TRANSPORTATION SUMMARY

- The site is on Statesville Road, a State-maintained major thoroughfare, south of Spector Drive, a City-maintained local street. A Traffic Impact Study (TIS) is not needed for this site. CDOT will work with the petitioner during the permitting process to ensure all required streetscape and transportation related ordinance requirements are complied with for adequate access and connectivity to the site and surrounding network.
