  - b. For the McIntyre Farm property, that segment is anticipated to be widened one day but is not funded.

  - a. McIntyre Farm Monument CLTWater has a 16" water distribution main that asbuilt drawings show 9' off the edge of pavement toward the monument. This water main was installed in 1976 obviously while the Monument was in place. I would hope that any future repairs or replacement could work around the monument as well but wanted to make you aware that there is always the possibility it could be in conflict.
  - b. Wall & Church Marker CLTWater has a 8" sanitary sewer line in the r/w between the wall and back of curb. It was installed in 2019 and shouldn't need replacing for many, many years. Obviously, construction worked around the wall in 2019 but also wanted you to know the line is there.
