The bill would not have a direct impact on LIHTC and/or Housing Trust Fund (HTF) projects per se. LIHTC/HTF projects would be funded/advanced/operated just as they were prior to Council's enactment of the Source of Income in City Supported Policy in July 2022. However, if HB551 is passed as written, it would adversely impact the City of Charlotte's policy intent to ensure that voucher / rental subsidy holders in city supported housing are not denied housing due solely to their source of income.
CM Mayfield	13. Non-Profit Partner Funding for Single-Family Rehabilitation What is the history and what projects have "For the Struggle" completed to qualify for funding. Is this the organization we learned about at the Council Housing Summit earlier this year that focuses on employing our local community?	For The Struggle (FTS), founded in 2019, is a small, Charlotte-based and minority-led non-profit focused on a range of issues related to racial and social injustice. Critical Home Repairs is one programming area for FTS and the organization responded to the city's Request for Qualifications (issued in January 2023) to rehabilitate single-family housing units of low and moderate-income households FTS provided information on their team's experience and their ability to carry out the work effectively. Based on staff review of FTS's proposal, the organization was determined to meet the required qualifications and is one of the contractors recommended by staff to provide housing rehabilitation services in accordance with the April 24, 2023 Request for Council Action. If approved, this will be the city's first housing rehabilitation contract with FTS, however Mecklenburg County does currently contract with FTS to perform critical repairs. FTS has performed over 40 home repair projects funded by Mecklenburg County.
