AN ORDINANCE ORDERING THE DEMOLITION AND REMOVAL OF THE DWELLING AT 9336 PINEWOOD AVENUE PURSUANT TO THE HOUSING CODE OF THE CITY OF CHARLOTTE AND ARTICLE 19, PART 6, CHAPTER 160A OF THE GENERAL STATUTES OF NORTH CAROLINA, SAID BUILDING BEING THE PROPERTY OF UNKNOWN TRUSTEE OF THE FAMILY TRUST CREATED BY THE WILL OF EMMITT PRESTON OSBORNE 8236 DOUGLAS DRIVE CHARLOTTE, NC 28217

WHEREAS, the dwelling located at 9336 Pinewood Avenue in the City of Charlotte has been found by the Code Enforcement Official of the City of Charlotte to be in violation of the Housing Code of the City of Charlotte and the owners thereof have been ordered to demolish and remove said dwelling; and


