	28. 15-15985 Public Auction for Disposal of Surplus Equipment Pull for Comment: - Not convinced that the City is maximizing "useful life" of its rolling vehicle fleet Decommission threshold appears too liberal for some vehicle types, i.e. heavy-duty trucks, F-150s Many vehicles with mileage under 100K miles appear to be churned for age, being wrecked etc Serious consideration should be given to 150K minimum regardless of vehicle age unless wreck result in total loss In-house vehicle maintenance facility should support and justify higher mileage before decommission.	To provide additional clarifications for the vehicle replacements: On an annual basis Fleet Management works with user departments to replace vehicles and equipment based on four criteria: • age, • mileage, • maintenance costs, and • condition of body and mechanical components. In some instances, even with lower mileage, the projections show that it would cost less to sale and replace the vehicle than to repair and maintain it. It is also important to note that due to timing the report attached to the RCA covers all potential vehicles based on standard criteria. Additional reviews are conducted to finalize the auction items. Please see attached examples from tonight's surplus listing.
